

Operating and Visitor Rules of the Summer Stage

Article 1 – Introductory Provisions

1. The owner of the summer stage located on plot no. 73, cadastral area Vyšehrad, is the City of Prague. The site is managed by the National Cultural Monument Vyšehrad, a contributory organization of the City of Prague.
2. The operational period is from April 1st to October 31st, with operating hours according to the program schedule. The summer stage is used for cultural and social events organized by NKP Vyšehrad or other organizers authorized by NKP Vyšehrad. The seating capacity is 360 seats, the stage dimensions are 11 x 14 meters. The area is not equipped with a roof, lighting, or sound technology. Only a backstage area for actors (without toilets) and a sound technician's booth are available. Toilets for visitors are located near the basilica on Štulcova Street. For refreshments during events, the space of the summer stage can be used, or with prior approval from the site manager, the area on Bastion 38.
3. By entering the summer stage area, visitors agree to the terms of these operating rules. Upon request from an authorized person of the site manager or event organizer, visitors are required to present a valid ticket if their presence in the area is based on the purchase and proper presentation of a ticket. The ticket is valid exclusively for the specified day, time, and event.

Article 2 – Rules for Visitors

1. Every person entering the summer stage area is required to behave in a manner that does not endanger or disturb themselves or others and does not damage the area and its equipment. Visitors must follow the instructions of authorized persons of the site manager and event organizer and maintain cleanliness and order.
2. It is prohibited to enter the summer stage area with animals, except for assistance dogs for people with disabilities. Entry is also prohibited for persons suspected of being intoxicated or under the influence of drugs and other intoxicants, and persons in heavily soiled, inadequate, or otherwise inappropriate clothing and footwear.
3. Children under 15 years old are allowed to enter only when accompanied by an adult who is responsible for ensuring the child's behavior complies with these operating rules. Parents, legal guardians, adult companions, or pedagogical supervisors are responsible for minors or incapacitated persons in all areas.
4. Visitors to the summer stage may only move in designated areas (seating area and access paths) and are not allowed to enter areas reserved for technicians, actors, and other personnel.
5. Due to the nature of the area, which is a cultural monument, visitors must exercise extra caution when moving around the area. Please be aware of uneven terrain, steep staircases, and difficult conditions in case of rainy weather.
6. It is prohibited to bring drugs, toxic and intoxicating substances, glass and sharp objects, any weapons, explosives, flammable substances, oversized luggage, bicycles, scooters, and other dangerous items that could cause harm to health or property into the summer stage area.
7. Smoking (including electronic cigarettes) and any handling of open flames are prohibited in the summer stage area.
8. Placing any promotional materials and engaging in marketing and advertising activities is prohibited without prior approval from the site manager and event organizer.
9. Taking photos and making audio or video recordings during performances is prohibited without prior approval from the event organizer. Any photos or recordings made in the summer stage area or during events may not be used for commercial purposes without the event organizer's consent.

Article 3 – Visit by Persons with Limited Mobility

1. Due to the nature of the cultural monument and the natural amphitheater of the summer stage, significant technical reasons prevent the area from being adapted for persons with limited mobility. Visiting the summer stage is currently possible only under the following organizational conditions.
2. Visits by persons with limited mobility must be reported to the event organizer in advance. For events organized by National Cultural Monument Vyšehrad, contact can be made via email at pokladna@praha-vysehrad.cz or by phone at 222 513 505.
3. The capacity of blocked seats for persons with limited mobility is restricted depending on the nature of the event. Before purchasing a ticket, it is necessary to verify the availability of accessible seats with the event organizer.
4. A person with limited mobility must be accompanied by someone physically capable of assisting in their evacuation.

5. Entry to the summer stage area will be permitted to the pre-registered person with limited mobility if they arrive no later than 15 minutes before the event begins. Arrival must be reported to an authorized person of the event organizer. The operational entrance from the road below Bastion 38 is used for entry (further information will be provided by the event organizer).
6. To view the event, only designated seats in the area between the seating and stage (near the first row) can be used.
7. Usable restroom facilities for persons with limited mobility are located outside the summer stage area near the Basilica of Saints Peter and Paul on Štulcova Street.

Article 4 – Specific Provisions

1. Entry and stay in the summer stage area are conditional on compliance with applicable legal regulations and these operating rules. The site manager or event organizer reserves the right to deny entry or remove any person who does not comply with these rules, other legal regulations, or instructions from the organizer, or whose behavior is deemed inappropriate.
2. For safety reasons, the event organizer's authorized person has the right to conduct random personal security checks of visitors' luggage upon entry to the summer stage area. Every person entering the summer stage area agrees to this inspection. Refusal of inspection is grounds for denial of entry.
3. In case of inappropriate behavior by a visitor, the site manager or event organizer is authorized to call the Police of the Czech Republic.
4. Anyone who notices a defect in the area or equipment of the summer stage that threatens the safety of persons or poses a risk of property damage must immediately report such a defect to the site manager's authorized person or event organizer.
5. Any injury must be reported to the site manager's authorized person or event organizer.
6. The site manager and event organizer do not assume responsibility for lost or stolen items. They also do not assume liability for damages to property and health caused by violations of these operating rules or applicable legal regulations.
7. Every person entering the summer stage area agrees, without further notice, to the free use of their image or likeness as part of any visual recording, transmission, or reproduction of the event for commercial or promotional purposes, within the scope of displaying the whole or part of the seating area and access paths in connection with the operator, event organizer, and their contractual partners (e.g., sponsors).

Article 4 – Final Provisions

1. Visitors can report any defects and suggestions regarding the operation of the summer stage to the operator's staff or by email at sekretariat@praha-vysehrad.cz.
2. Visitors are responsible for violations of these operating rules and for any damages caused to the property of the City of Prague managed by NKP Vyšehrad, in accordance with applicable legal regulations.

These Operating and Visitor Rules were approved by the Director of National Cultural Monument Vyšehrad on August 30, 2024.
